- Considering** :
- a. whereas registration and Re-registration of Special Member of the Chamber of Commerce and Industry that initially stipulated in 1995 and has been several times revised, lastly in 2003, need to be further revised and implemented continually due to the revision of The Charter of Chamber of Commerce and Industry derived from the Special National Assembly of the Chamber of Commerce and Industry held in 2003 that had been acknowledge by the Presidential Decree Number 14 / 2004;
 - b. whereas for the above mentioned goal, The Board of Chairpersons of Indonesian Chamber of Commerce and Industry need to stipulate a decree on revision of Direction on registration and Re-registration of Special Member of the Chamber of Commerce and Industry;

- In Observance of** :
1. Law Number 1/1987 on the Chamber of Commerce and Industry, particularly Section 9 and Section 10;
 2. The Charter of Chamber of Commerce and Industry that had been acknowledge by the Presidential Decree Number 14/2004 on Consent on the Revision of The Charter of Chamber of Commerce and Industry;
 3. Results of the year 2004's Fourth National Assembly of the Chamber of Commerce and Industry;

- Bearing in Mind** :
1. Results of the National Chairpersons Assembly (Rapimnas) of the Chamber of Commerce and Industry (Kadin) since 1995, particularly that related to membership;
 2. The Results of the National Coordination Assembly meetings of the Organizational Committee (Rakornas Organisasi Kadin) since 1999, lastly held on 15 July 2004, particularly those related to revisions on registration and Re-registration of Special Member of the Chamber of Commerce and Industry;

Decide to

Stipulates: Direction on Registration and Re-registration of Special Membership of Chamber of Commerce and Industry.

Firstly : Direction on Registration and Re-registration of Special Membership of Chamber of Commerce and Industry mentioned on this Decree is as described on the Attachment of this Decree.

Secondly: Direction mentioned on the abovementioned First dictum shall be applied annually commenced from the year of 2005.

Thirdly : All the Board of Provincial and District/City Chamber of Commerce and Industry in Indonesia shall implement the registration and Re-registration Special Member Chamber of Commerce and Industry according to the abovementioned First Dictum;

- Fourthly : Organizational sanctions according to the Charter of Kadin and other applicable organizational regulation shall be applied to a Board of any level of Chamber of Commerce and Industry not implements such provisions of the Direction mentioned on the First dictum.
- Fifthly : The Deputy Chairperson of Indonesian Chamber of Commerce and Industry's Organization and Membership and its committees shall observe the implementation of the abovementioned First dictum, and shall periodically report the result to The Board of Indonesian Chamber of Commerce and Industry thru General Chairperson.
- Sixthly : This Decree shall enter into force upon the date of its stipulation.
